CAMBODIA VISA EXEMPTION

Regular passport holders from 8 countries below do not need a tourist visa for Cambodia

Exemption list:

- Visitors from the following countries are eligible for a 14-day stay without a visa: Myanmar, Thailand
- Visitors from the following countries are eligible for a 15-day stay without a visa: Seychelles
- Visitors from the following countries are eligible for a 30-day stay without a visa: Indonesia, Malaysia, Philippines, Singapore, Vietnam

Special note:

Nationals of these countries can enter Cambodia without a visa for a specific period of time, which varies depending on the country. However, it is important to note that visa exemptions are subject to change, so it is always advisable to check with the nearest Cambodian embassy or consulate before travel.

CAMBODIA E-VISA

E-visa is granted by the Ministry of Foreign Affairs and International Cooperation to enable 54 countries to apply for a visa online.

The list includes Andorra, Australia, Austria, Belgium, Brazil, Bulgaria, Canada, China, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, India, Ireland, Israel, Italy, Japan, Kazakhstan, Latvia, Lithuania, Luxembourg, Malta, Mexico, Monaco, Mongolia, Montenegro, Netherlands, New Zealand, North Macedonia, Norway, Poland, Portugal, Romania, Russian Federation, San Marino, Serbia, Slovakia, Slovenia, South Korea, Spain, Sweden, Switzerland, Taiwan, United Arab Emirates, United Kingdom, United States of America, Vatican City

Cambodia e-visa requirement:

- A passport is valid for at least six months beyond the duration of your stay in Cambodia.
- A recent passport-sized photo in digital format that meets the specified requirements.
- A valid email address to receive the e-Visa approval letter.
- A means of payment to pay the e-Visa fee, such as a credit or debit card.
- E-visa fee of USD 36 (non-refundable)

Processing time:

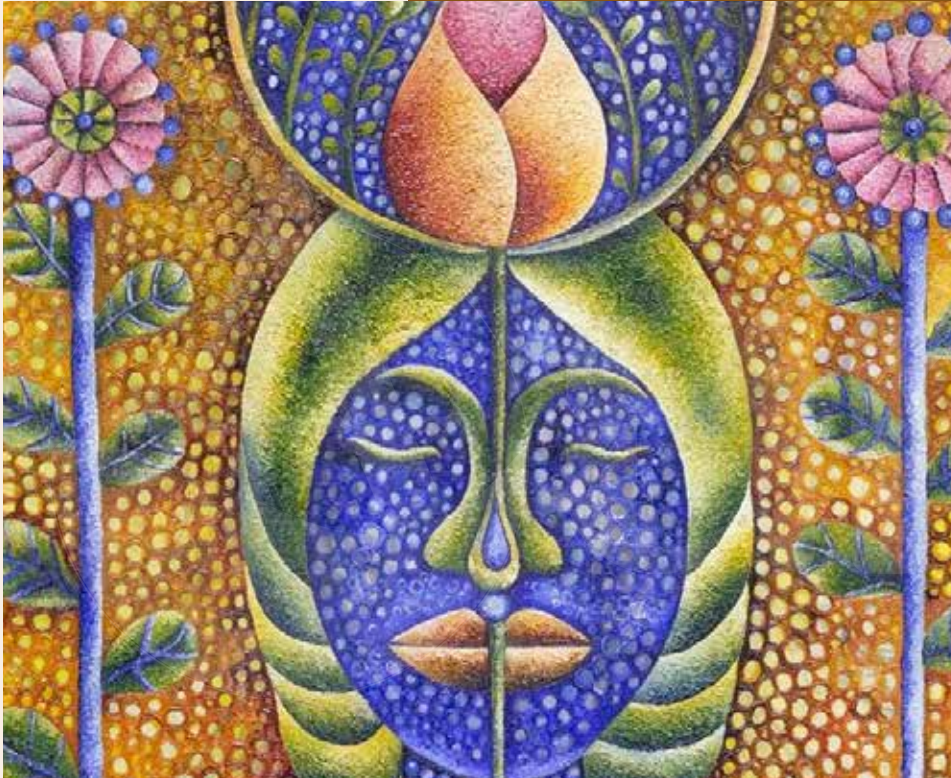
The processing time for a Cambodia e-visa is typically between 1 and 3 business days. However, it can take up to a week or more during peak travel season or if there are issues with the application. It is recommended to apply at least a week in advance of your intended travel date to allow for any unforeseen delays.

Note:

- The e-visa is only valid for entry at the following Cambodian airports: Phnom Penh, Siem Reap, and Sihanoukville.
- You must print out a copy of your e-visa approval letter and bring it with you when you travel to Cambodia.
- E-visa: can now be used through a Cambodia e-Arrival card (which means travelers do not need to go to the Cambodia e-visa website anymore). The e-visa can be applied through an e-arrival card is USD 36
- The visa fee is subject to change



CAMBODIA E-ARRIVAL



Cambodia e-Arrival aims to expedite and modernize the entry process. The digital card replaces the traditional paper-based immigration form, health form, and customs declaration, consolidating them into a single, convenient online portal. Travelers can access the e-Arrival system up to 7 days before their arrival.

It is available through two channels:

- Official Website: The official government website, <https://arrival.gov.kh/>, allows for online submission of the e-Arrival card.
- Mobile App: The Cambodia e-Arrival app is available on the Apple App Store and Google Play Store. It offers a convenient mobile platform for completing the e-Arrival card.

Important note:

- Cambodia e-Arrival card is the new APP that allows a complete application including Visa, Immigration, and Customs.
- All travelers are required to fill in the Cambodia e-Arrival even if they have been granted VISA.
- When filling in the information through this App, there are 9 steps to complete until you get your visa paid and a QR code is provided. Any missing steps are an invalid application, yet, tourists can resume your application.
- In case tourists already have an e-visa, they can choose the "Already have an e-visa" option on the App and go through other steps until the QR code is provided.
- E-arrival can only be used when entering through Cambodia's international airports. If tourists enter through land ports or water ports, they will still have to apply on arrival traditionally through a manual form.

CAMBODIA E-ARRIVAL

How to complete the e-Arrival application step by step:

Stage 1:

Step 1: Open the APP

- . Go to Foreign Visitor
- . Click Individual Submission

Step 2: Create a profile

- . Choose Add New Profile and fill in the required information
- . Click: SAVE after filling in all the needed information

Stage 2: There are 9 nine steps:

Step 1: Select visa options: Please select the visa type (T, E, K, D) you would like to apply for visa T (tourism visa which is valid for 30 days)

Step 2: Period of Travel to Cambodia – please enter the date of arrival and departure

Step 7: Goods declaration – please choose your answer YES or NO:

- . Have good to declare?: **Choose Yes or No**
- . Are you carrying foreign currency or monetary instruments worth over US\$10000 or its equivalent?: **Choose Yes or No**

Step 8: Profile and Passport Details

Please go to the bottom of the page and tick the confirmation box:

"I have confirmed that all the information I have provided is correct. Otherwise, you may face Cambodia legal's consequences"

Step 9: Select payment options:

- . Visa card
- . JCB

Important note:

- . You will receive a notification via email and e-Arrival app after successful payment
- . If your visa is not approved by the time you arrive in Cambodia, you can visit the visa-on-arrival counter to get your visa approval instantly
- . All payment is final and non-refundable
- . The e-visa applied via e-arrival cost USD 36
- . After payment, you will receive a QR CODE for your e-visa. Save it carefully to use upon your arrival in Cambodia.

CAMBODIA VISA ON ARRIVAL



The visa on arrival (VOA) is only available for certain nationalities, and it may be subject to change. It is always a good idea to check with the Cambodian embassy or consulate in your country before traveling to Vietnam to confirm the latest visa requirements. Please follow the below steps:

Step 1: Fill out the Cambodia visa application form: You can obtain the form upon arrival in Cambodia, or you can download it from the Cambodian Embassy website and fill it out in advance.

Step 2: Provide a passport-sized photo: You will need to provide a recent passport-sized photo along with your application.

Step 3: Pay the visa fee of USD 30

Step 4: Wait for the processing.

Important note

- Make sure that the passport has at least 6 months of validity from the entry date ahead.
- The Visa on Arrival is worked if travelers enter Cambodia via Phnom Penh International Airport & Siem Reap International Airport.
- You need to prepare some cash (US dollars or Cambodian riel) for the stamping fee since no credit cards are accepted.
- Your visa will be processed by immigration officials upon arrival in Cambodia. The processing time may vary, so be prepared to wait.
- Once processed, Visa service cannot be canceled, so we require you to make full payment in advance and non-refundable.

CAMBODIA VISA FOR RESTRICTED NATIONALITIES

*There are countries those are restricted their citizens to apply for visas to Cambodia.
And we are strictly requested to process according to
Cambodia's regulations.*

Restricted list:

The list includes Afghanistan, Algeria, Arab Saudi, Bangladesh, Bulgaria, Iran, Iraq, Nigeria, Pakistan, Sri Lanka, Sudan

VOA terms & conditions for restricted passport holders:

Terms:

- Service fees vary depending on nationality and the date of processing the VOA.
- The validity depends on the travelers' stay time in Cambodia (maximum of 30 days).
- Contact us for a case-by-case quotation.

Conditions:

- Package tour with Aurora Travel.
- Passport copies of all passengers.
- Copy of international return flight (In and out of Cambodia).
- Full prepayment (Non-refundable).
- Travel insurance.

Note:

The visa policies and requirements may change over time, so it is recommended to check with the relevant embassy or consulate for the latest information.
